Called to Order

Update on B-CON

Jacob reported this program is going well and continues to have a lot of requests for more information from the region. Chad Curry has been a good resource and he has the bleeding manikins. Chad will be training all school nurses in Region 17 during the month of June. Wendi did report that any school that does the training will be given a Stop the Bleed kit for every AED they have. Anyone that is instructing the course needs to complete the form that is posted on the SPEMS and B-RAC website. Wendi reported to be qualified as a train the trainer you must be a nurse with current TNCC or ATCN certification; EMS certified personnel, or a physician with current ATLS certification.

GETAC Trauma System Committee - Initiatives

Wendi reported that the state trauma system committee met and is working on a statewide PI committee that will be focusing on critical care. The committee will be developing a PI program to review

hemorrhage, shock, spinal injuries and TBIs. They will be rolling out best practices to the region.

High Priority Critical Care

There will be criteria to monitor: examples:

- a. Shock – B/P less than 90.
- b. Triage decisions – it will be important that EMS triages with a tier system. This will include patients that are transported to free-standing ERs.

Time Sensitive Definitive Care

- c. Orthopedic injuries will receive antibiotics within one hour of admission to the ER.
- d. Lead facilities will work on the criteria and the other ERs will follow the protocols.

Data Management Workgroup

Trauma Quality Improvement program will review trends. Examples:

- a. Best practices
- b. Massive transfusions
- c. Geriatric
- d. Palliative care

Burn Center Workgroup

This workgroup will work with the ABA guidelines. The guidelines will focus on usage of burn units.
