- **1.** DSHS Texas AIM Severe Hypertension in Pregnancy learning collaborative was completed in 2024.
- 2. TCHMB obstetrics committee state initiative "Recognition and Response to Postpartum Preeclampsia in the ED" was completed in 2024, and in the process of being published and developing a toolkit for hospitals.
- 3. DSHS Texas AIM and TCHMB have partnered for future statewide maternal projects. Enrollment for the new bundle "Sepsis in Obstetric Care" is open through February 28, 2025. The TSA-B region is in Cohort 1 for the learning collaborative events.
